

RESOLUTION 17-2018  
VILLAGE OF GILBERTS

RESOLUTION WAIVING CERTAIN COMPETITIVE BIDDING AND APPROVING A  
CONTRACT WITH SCHROEDER ASPHALT SERVICES, INC FOR THE 2018  
GILBERTS STREET IMPROVEMENT PROGRAM

WHEREAS, the Village of Gilberts intends to design, construct, and complete certain roadway improvements in the Industrial Park area of the Village, and along Galligan Road; and

WHEREAS, the Village's engineering firm, Robinson Engineering solicited three proposals and received two responses for the 2018 Gilberts Street Improvement Program, and upon evaluation by Robinson Engineering, Schroeder Asphalt Services, Inc, submitted the lowest responsible and responsive proposal; and

WHEREAS, the Village finds it to be in the best interest of the Village to waive competitive bidding and to approve a contract with Schroeder Asphalt Services, Inc., for the completion of the 2018 Gilberts Street Improvement Program.

Now, Be it Resolved by the President and Board of Trustees of the Village of Gilberts Kane County, Illinois that:

**Section 1:** The Village of Gilberts hereby waives the competitive bidding requirements for the street project pursuant to its authority under state law.

**Section 2:** The Village of Gilberts hereby approves and authorizes the Village President and Village Clerk to execute a contract with Schroeder Asphalt Services, Inc., substantially in the form attached to, and made a part, of this Resolution as Exhibit A.

**Section 3:** This resolution shall be in full force and in effect from and after its passage and approval pursuant to law.
