

A RESOLUTION ADOPTING THE AMENDED VILLAGE OF GILBERTS' EMERGENCY MANAGEMENT PLAN

WHEREAS, the Village of Gilberts is a non-home rule unit of local government; and

WHEREAS, the Village Board of Trustees of the Village of Gilberts finds it to be in the best interest of the Village to adopt the amended Emergency Management Plan;

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS AS FOLLOWS:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as set forth in this Section 1.

Section 2. Adoption of Policy. The Board of Trustees hereby approves and adopts the Village of Gilberts Emergency Management Plan, with the last revision date of August, 2016

Section 3. Confidential Exemption. As provided by law the Emergency Management Plan is exempted from disclosure pursuant to the Illinois Freedom of Information Act, 5ILCS 140/1 (c) 7 (1) (v).

Section 4. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in accordance with law.
