

MINUTES FOR VILLAGE OF GILBERTS BOARD OF TRUSTEES MEETING

1. CALL TO ORDER / PLEDGE OF ALLEGIANCE

A. Public Hearing on a Proposed Third Amendment to the Annexation and Development Agreement for Gilberts Town Center –

A Motion was made by Trustee Farrell and seconded by Trustee Hacker to Open the Public Hearing for the Proposed Third amendment to the Annexation and Development Agreement for Gilberts Town Center. Roll call vote: Trustees Allen, Zambetti, Farrell, Hacker, and Corbett voted Aye. 0-nays, 0-abstained. Motion carried.

Isabelle Bertone of 92 Valencia – Ms. Bertone approached the Board and asked who is in charge of monitoring the monotony of the homes that are going to be built. President Zirk stated that the development agreement has a monotony division that is monitored by the builders and the Village building department.

Marianne Giacal of 108 Valencia – Ms. approached the Board and asked if basements are going to be required. President Zirk stated that, since the current ordinance requires basements and the Developer did not ask for a deviation of that, they will be required to have basements.

A Motion was made by Trustee Farrell and seconded by Trustee Allen to Close the Public Hearing for the Proposed Third amendment to the Annexation and Development Agreement for Gilberts Town Center.
