<u>Section 2.</u> <u>Approval; Authorization.</u> The Village Board of Trustees hereby authorizes the Village Administrator to execute the necessary documents to facilitate the purchase of a replacement lift station pump for the Meadows Lift Station from Xylem Company in an amount not to exceed \$13,000.

Section 3. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
