RESOLUTION 16-2021

A RESOLUTION AUTHORIZING APPROVAL OF AN AGREEMENT WITH O'CARROLL ELECTRIC FOR THE INSTALLATION OF PERMANENT POWER TO VILLAGE ENTRYWAY SIGNS IN AN AMOUNT NOT TO EXCEED \$12,410

WHEREAS, the Village of Gilberts ("Village") has three entryway monument signs which are lit with small solar panels and battery systems; and

WHEREAS, due to the combination of the small solar system and Illinois weather the solar system is frequently unable to keep up with the power draw; and

WHEREAS, adequate funds were included in the FY2022 Budget to install permanent electrical power to each of the signs; and

WHEREAS, the Public Works Department contacted O'Carroll Electric to provide a quote due to their familiarity and previous work on the entryway signs; and

WHEREAS, the Village's purchasing guidelines require Village Board consideration of purchases in excess of \$10,000.

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

- **Section 1.** Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.
- <u>Section 2</u>. <u>Approval; Authorization</u>. The Village Board of Trustees hereby authorizes the Village Administrator to execute an agreement with O'Carroll Electric for the installation of permanent power to the Village's entryway signs in an amount not-to-exceed \$12,410.
- Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the agreement with O'Carroll Electric, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).
- Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.

- Sign I (Galligan Road)
 - Description: Draw power from water tower panel, trench to sign, install 12V power supply, install photo eye and weatherproof box with GFI (120V)
 - Project Cost: \$1,685
- Sign II (Route 72)
 - Description: ComEd to install transformer on pole, O'Carroll to install 200A
 meter socket, trench from pole to sign, install 12-circuit panel w/ GFCl, 12V
 power supply, grounding rod, and photo eye; ComEd to make final connection
 at base of pole
 - Project Cost: \$2,575
- Sign III (Big Timber)
 - Description: O'Carroll to horizontally bore 1" poly under Big Timber Road to
 pole on south side of intersection and pull (3) #6 wire; install 200A meter
 socket, 12-circuit panel w/ GFCl and bell box, grounding rod, 12V power supply,
 and photo eye
 - Project Cost \$7,200
