## A RESOLUTION AUTHORIZING THE PURCHASE OF WATER METERS FROM FERGUSON WATERWORKS FOR THE VILLAGE'S WATER METER REPLACEMENT PROGRAM IN A NOT TO EXCEEED AMOUNT OF \$15,500

WHEREAS, the Village of Gilberts ("Village") started a multi-year water meter replacement program in 2013; and

WHEREAS, there are a remaining 48 water meters from the original replacement program to be replaced in residential homes; and

WHEREAS, a quote was solicited from the Village's water meter supplier Ferguson Waterworks; and

WHEREAS, funds were included in the FY2023 Budget for the purchase of new water meters;

## THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

**Section 1. Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

<u>Section 2</u>. <u>Approval: Authorization</u>. The Village Board of Trustees hereby authorizes the Village Administrator to execute agreements and other necessary documents with Ferguson Waterworks for the purchase of 48 water meters for the Village's meter replacement program in an amount not-to-exceed \$15,500.

<u>Section 3.</u> <u>Effective Date</u>. This Resolution shall be in full force and effect after its approval in the manner provided by law.
