The Village Board of Trustees hereby authorizes the Village Administrator, upon receipt of all final contract documents to the satisfaction of the Village Administrator and Village Engineer, to execute the necessary documents attached as with Schroeder Asphalt Service, Inc. for the 2023 Roadway Resurfacing Program in an amount not-to-exceed \$461,188.00.
- Section 3. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
