## Huntley Road at Galligan Road Intersection Reconstruction Project Kane County Section No. 08-00112-00-CH

Starting Tuesday, January 29, 2019, (weather permitting) **new traffic signals are anticipated to be operational at the intersection of Huntley Road at Galligan Road** in unincorporated Gilberts, Kane County. Crews have added left and right turn lanes on Galligan Road, a right turn lane for east bound Huntley Road, and a left turn lane for west bound Huntley Road. This traffic pattern is the final traffic configuration for the intersection. There is minor punch list work remaining that may require periodic temporary daily single lane closures with flaggers directing traffic. Construction work hours will be from **6:00 am until 5:00 pm Monday through Saturday. The remaining work will be completed in the spring when the weather is above freezing.**

Huntley Road	500 ft east of Galligan Rd	300 ft east of Square Barn Rd
Galligan Road	1300 ft south of Huntley Rd	Huntley Rd

The above-mentioned roads will remain open during construction, but may be reduced to one lane of travel using temporary daily lane closures. Motorists need to be prepared to reduce their speed, exercise caution, and be extra alert. Motorists must watch for construction workers, construction vehicles entering or leaving the site, and obey flaggers and other traffic control devices within the work zone. **Motorists should expect long delays while traveling through the work areas.** Motorists should add additional time to their commutes and consider the use of alternate routes while this work is being completed.

A reminder – **it is illegal for drivers to talk on a cell phone while driving through a highway construction work zone.**

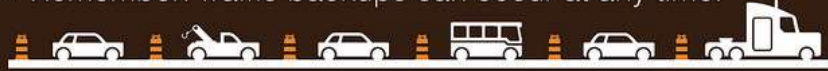
## Work Zone Safety Tips

- Pay attention; conditions can change quickly.



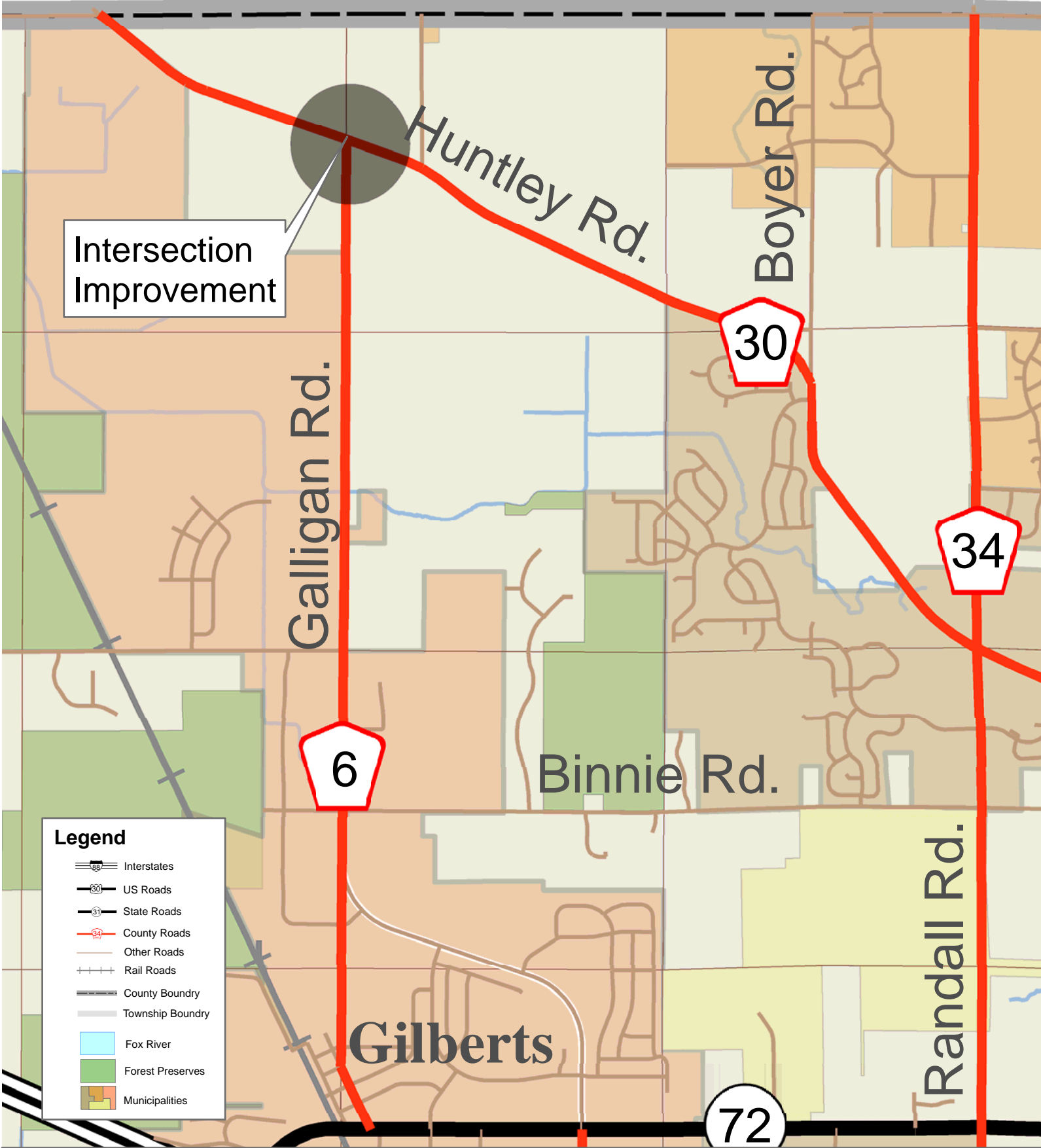
- If possible, move over for workers.

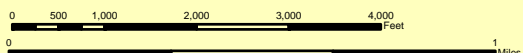


Intersection Improvement
