

- Licenses under this chapter shall be issued only to bona fide nonprofit, religious, charitable, labor, business, fraternal, educational or veterans' organizations that operate without profit to their members, which have been in existence continuously for a period of five years immediately before making application
- The license application must contain a sworn statement, signed by an officer of the organization, attesting to the not for profit character.
- The entire net proceeds of the proposed raffle will be exclusively devoted to the lawful purpose of the organization seeking the license.
- No person except a bona fide member of the sponsoring organization shall participate in the management or operation of the raffle.
- No person shall receive any remuneration or profit for participating in the management or operation of the proposed raffle, except the licensed organization or designated beneficiary of a licensed nonprofit fundraising organization.
- The real value of all prizes or merchandise awarded by a licensee in a single raffle shall not exceed \$500,000.00. The maximum retail value of each prize awarded by a licensee in a single raffle shall not exceed \$500,000.00. The maximum price which may be charged for each raffle chance issued or sold shall not exceed \$200.00. The maximum number of days during which chances may be sold may not exceed 210 days.
