AN ORDINANCE AMENDING CHAPTER 2 OF TITLE 3 OF THE VILLAGE CODE TO INCREASE THE NUMBER OF "A" LIQUOR LICENSES

WHEREAS, the Village is authorized by the Illinois Liquor Control Act, 235 ILCS 5/1 et seq. to license and regulate the sale of alcoholic beverages in the Village; and

WHEREAS, the Village has established local liquor license regulations in Chapter 2 of Title 3 of the Gilberts Village Code; and

WHEREAS, the Village has determined it to be in the best interests of the Village and its residents to consider amendments to the Gilberts Village Code to add an additional Class "A" liquor license, as set forth in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Gilberts, Kane County, Illinois, as follows:

Section 1: The recitals set forth above are incorporated into this Section 1 as if set forth herein.

Section 2: Section 3-2-9 "Number of Licenses" of Chapter 3-2 "Liquor Control" of the Gilberts Village Code shall be amended by adding the following underline text and deleting the following stricken text:

"A. The liquor commissioner shall be authorized to issue the following number of licenses to be outstanding at any one time:
