ORDINANCE NO. 25-2016

AN ORDINANCE AMENDING THE GILBERTS VILLAGE CODE  
CONCERNING WATER AND SANITARY SEWAGE RATES  
WITHIN THE CORPORATE LIMITS

WHEREAS, pursuant to state statute, the Village Board has the authority to operate and maintain a water and sanitary sewer system, and to charge a user fees to maintain and operate the systems; and

WHEREAS, the Village Board has determined that it is in the best interests of the financial sustainability of the Water and Sewer Enterprise Fund to increase the rates; and

WHEREAS, the Village has studied the long range financial plan for the Village's Water and Sewer Enterprise Fund and has discovered that the current user fees charged over time have not increased at a rate commensurate with inflation or reflect the new IEPA unfunded mandates; and

THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS AS FOLLOWS:

**Section 1. Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Ordinance as though set forth in this Section 1.

**Section 2. Amendment.** Section 2-4-5-3, entitled "Water and Sanitary Sewage Rates within the Corporate Limits" is amended as follows, with additions identified as underlined and deletions identified by strikethrough:

All uses:	
Water only, per 1,000 gallons	<del>\$4.50</del> <u>\$5.50</u>
Sanitary sewage only, per 1,000 gallons of metered water usage	<del>\$4.50</del> <u>\$5.50</u>
Water and sanitary sewage, per 1,000 gallons of water used	<del>\$9.00</del> <u>\$11.00</u>
Minimum billing	<del>\$10.00</del> <u>\$11.00</u> per month <del>\$20.00</del> <u>\$22.00</u> per billing cycle

**Section 3. Severability.** In the event a court finds this Ordinance or any provision hereof to be invalid or unenforceable as applied, that finding will not affect the validity of the remaining provisions of this Ordinance and the application thereof to the greatest extent permitted by law.

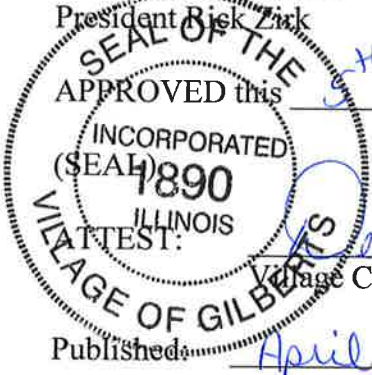
**Section 4. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict with this Ordinance are repealed; provided that nothing in this Ordinance will affect any rights, actions, or claims that may have accrued to the Village prior to the Ordinance's effective date.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its approval in the manner provided by law.
