AN ORDINANCE UPDATING THE OFFICIAL ZONING MAP OF THE VILLAGE OF GILBERTS

WHEREAS, the Village of Gilberts is an Illinois Municipal Corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, the corporate authorities of the Village are required to publish and make available to the public an Official Zoning Map each year pursuant to 65 ILCS 5/11-13-19; and

WHEREAS, on January 11, 2017, the Plan Commission conducted a public meeting on the annual update to the Village of Gilbert's Official Zoning Map and recommended approval of the updated Official Zoning Map, a copy of which is attached as **Exhibit A**.

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Gilberts, Kane County, Illinois pursuant to its statutory powers, as follows:

Section 1. The recitals set forth above are hereby incorporated into and made a part of this Ordinance as though set forth in this Section 1.

Section 2. The Official Zoning Map of the Village is updated and shall be as depicted on Exhibit A which is attached to this Ordinance. Copies of the Official Zoning Map shall be published and made available to the public for a charge.

Section 3. Upon its passage and approval according to law, this Ordinance shall, by authority of the Board of Trustees, be published in pamphlet form.
