ORDINANCE

VILLAGE OF GILBERTS

**An Ordinance Naming and Renaming Certain Streets Within the Village of Gilberts**

**WHEREAS**, the Village of Gilberts (“Village”) is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

**WHEREAS**, Section 11-80-19 of the Illinois Municipal Code grants the corporate authorities of the Village the power to name originally and then change the name of any street, avenue, alley or other public place; and

**WHEREAS**, the Village has determined that the street commonly known as “East Drive,” as more fully depicted on Exhibit A, should be renamed as “East End Drive;” and

**WHEREAS**, the Village has determined that the street commonly known as “Elgin Avenue,” as more fully depicted on Exhibit B, should be renamed as “Higgins Road;” and

**WHEREAS**, the Village has determined that the street that is located directly west of Tyrell Road and directly south of the Jane Addams Memorial Tollway, as more fully depicted on Exhibit C, be named “Raymond Drive.”

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS**, as follows:

**Section 1. Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Ordinance as though set forth in this Section 1.

**Section 2. Renaming of “East Drive.”** The President and Village Board of Trustees hereby renames the street commonly known as “East Drive,” as depicted on Exhibit A, to “East End Drive.”

**Section 3. Renaming of “Elgin Avenue.”** The President and Village Board of Trustees hereby renames the street commonly known as “Elgin Avenue,” as depicted on Exhibit B, to “Higgins Road.”

**Section 4. Naming of “Raymond Drive.”** The President and Village Board of Trustees hereby name the street that is located directly west of Tyrell Road and directly south of the Jane Addams Memorial Tollway, as more fully depicted on Exhibit C, “Raymond Drive.”

**Section 5. Notice.** The Village Clerk is hereby directed to send a copy of this Ordinance by certified mail, return receipt requested, to the Kane County Clerk and the United States Post Office for Gilberts, Illinois (60136) as required by 65 ILCIS 5/11-80-19. The Village Clerk is also authorized and directed to record this Ordinance with the Office of the Kane County Recorder of Deeds.

**Section 6. Conflict.** All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

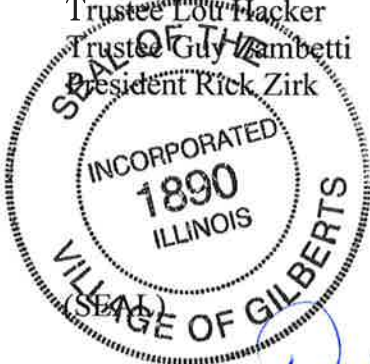
**Section 7. Effective Date.** This Ordinance shall be in full force and effect 30 days after a copy of this Ordinance has been sent to the Kane County Clerk and the United States Post Office for Gilberts, Illinois (60136), as designated by the certified mail return receipt.

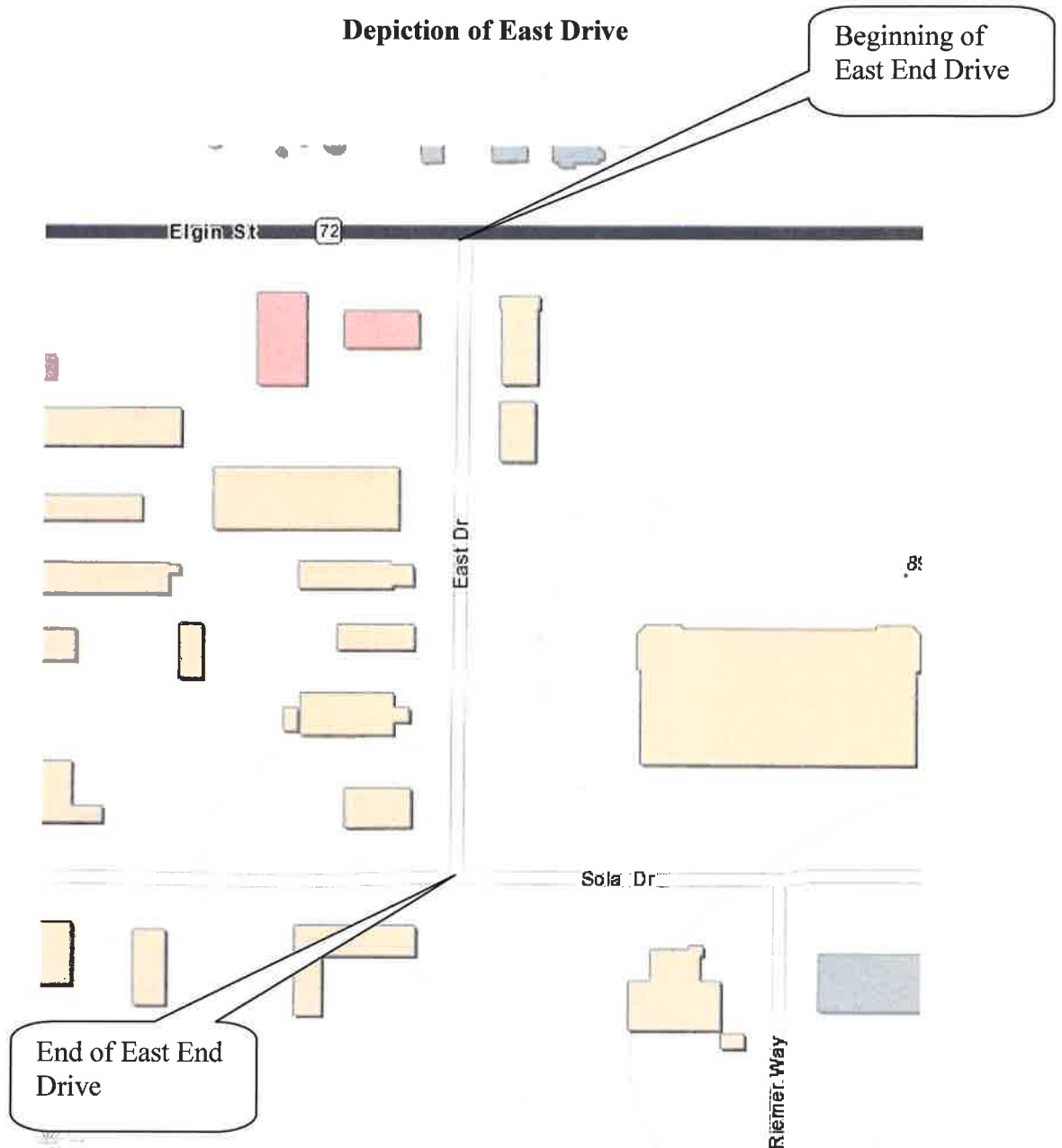

**Depiction of East Drive**

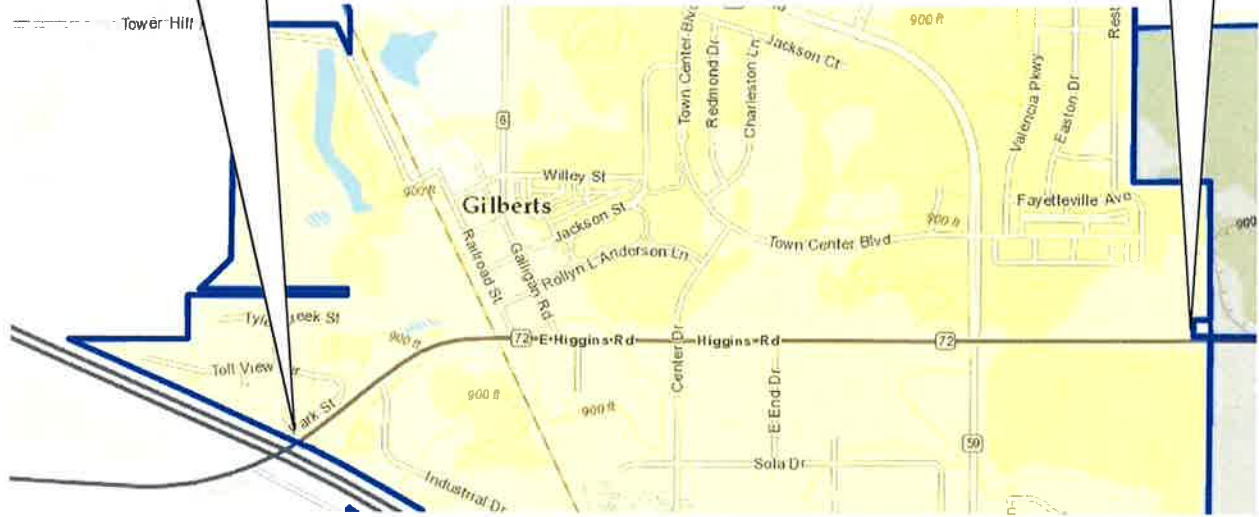
