**AN ORDINANCE AMENDING THE VILLAGE OF GILBERTS
CODE CHAPTER 4 "LITTER CONTROL"**

WHEREAS, the Village has determined it to be in the best interests of the Village and its residents to consider an amendment to the Gilberts Village Code.

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Gilberts, Kane County, Illinois pursuant to its non-home rule powers, as follows:

Section 1. Amendment. Chapter 4, entitled "Litter Control" of Title 4, entitled "Health, Sanitation and Environment," is hereby amended to add a new Section 4-4-2, which new section shall state as follows:

4-4-2 Local Refuse Regulations:

- A. No trash, garbage, yard or landscape waste, disposables or debris of any nature shall be placed within any street right-of-way, parkway, or area adjacent thereto in the Village sooner than 6:00 p.m. of the day prior to the day that such materials are scheduled or intended to be picked up for commercial disposal.
- B. All garbage cans, yard waste containers and refuse containers shall be removed from the right-of-way, parkway, or area adjacent thereto no later than 10:00 p.m. of the same day the refuse containers have been or were to be emptied.
- C. It shall be the joint responsibility of each resident or owner of the subject property to comply with the terms of this section 4-4-2. Any person found to be in violation hereof shall be subject to the general penalty provided in Title 1, Chapter 4 of this code.

Section 2. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 3. Repeal and Saving Clause. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Gilberts prior to the effective date of this ordinance.

Section 4. Effective Date. This ordinance shall be in full force and effect from and after its approval in the manner provided by law.
