ORDINANCE 02-2023

AN ORDINANCE AMENDING THE VILLAGE OF GILBERT'S FISCAL YEAR

WHEREAS, The Village of Gilberts (the "Village") is an Illinois municipal corporation organized and operating pursuant to Article VII of the Illinois Constitution of 1970 and the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*); and

WHEREAS, The Village desires to amend the Village of Gilberts Municipal Code to establish a new fiscal year corresponding with the calendar year, commencing on January 1, 2024.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, KANE COUNTY, ILLINOIS, as follows:

SECTION 1. The foregoing recitals are hereby incorporated into this Ordinance as though fully set forth in this Section 1.

SECTION 2. Title 2, "FINANCE AND TAXATION," Chapter 1, "GENERAL FINANCE PROVISIONS" of the Gilberts Code of Ordinances, is hereby amended by adding new Section 2-1-2, "Fiscal Year," as follows (additions in **bold and underlined** and deletions in **bold and strikethrough**):

2-1-2. - Fiscal Year.

The fiscal year of the Village shall begin on January 1 in each year, and end on December 31 of each year.

<u>SECTION 3</u>. Title 2, "FINANCE AND TAXATION," Chapter 6, "BUDGET OFFICER FINANCE SYSTEM," Section 2, "Budget Officer," of the Gilberts Code of Ordinances, is hereby amended as follows (additions in <u>bold and underlined</u> and deletions in <u>bold and strikethrough</u>; omitted language is not intended to be amended):

2-6-2. - Budget Officer.

A. Reserved. Appointment; Term; Removal. A budget officer shall be appointed by the village president, with the advice and consent of the board of trustees, for a one year term expiring on April 30 of each year. Removal from office shall be in accordance with applicable state law and applicable contractual provisions, if any. The budget officer may concurrently hold another nonconflicting municipal office, either elected or appointed.

SECTION 4. SEVERABILITY. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent

jurisdiction, all valid parts that are severable from the invalid pars shall remain in full force and effect. If any part of this Ordinance is found to be invalid in any one or more of its several applications, all valid applications shall remain in effect.

SECTION 5. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however that nothing in this Ordinance shall affect any rights, actions, or causes of action which shall have accrued to the Village of Gilberts prior to the effective date of this Ordinance.

SECTION 6. EFFECTIVE DATE. This Ordinance shall only be effective upon the passage, approval, and publication in the manner required by law, but not before December 31, 2023.
