

ORDINANCE NO. 19A-2024

**AN ORDINANCE AMENDING THE VILLAGE CODE
REGARDING SALARIES FOR ELECTED OFFICIALS**

WHEREAS, the Village of Gilberts (“Village”) is an Illinois municipality organized and operating in accordance with the Illinois Constitution of 1970 and the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*) (“Code”); and

WHEREAS, the Village has previously established the salaries and compensation for municipal officers, including the elected members of the Village’s Corporate Authorities, pursuant to Section 1-6-1 of the Gilberts Village Code; and

WHEREAS, pursuant to the Illinois Constitution and the Illinois Municipal Code, a salary fixed by ordinance for an elected officer must be passed at least 180 days before the start of the officer’s term and must remain constant for the duration of the officer’s current term; and

WHEREAS, the Village Board of Trustees wish to revise the salaries for those elected officials who will take office in 2025 and thereafter, as set forth in this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES of the Village of Gilberts, Kane County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals are incorporated as though fully set forth in this Section 1.

Section 2. Amendment to Section 1-6-1 of the Village Code. Section 1, entitled “Compensation,” of Chapter 6, entitled “Village Officers and Personnel,” of Title 1, entitled “Administration,” is hereby amended as follows (additions in **bold and underline**; deletions in **~~bold and strikethrough~~**):

“1-6-1. – Compensation.

A. *President.*

1. *Salary of the President.* The president shall receive an annual salary of \$~~6,000.00~~ **\$11,000.00**, payable in monthly installments.
2. *Acting President.* In the event the office of president is vacated prior to the end of a term said office shall be filed pursuant to the Illinois Municipal Code. The salary of the acting president shall be the current salary of the president.

B. *Trustees.*

1. *Salary of Trustees.*

- a. Except as provided in subsection B.1.b. of this section, the village trustees shall receive an annual salary of ~~\$3,000.00~~ \$4,500.00, payable in monthly installments.
- b. Any village trustee elected in ~~2017~~2025, or at any election thereafter, shall receive a stipend of \$125.00 for each village board or committee of the whole meeting actually attended by the trustee in a month, provided that the total monthly stipend paid to a village trustee shall not exceed ~~\$250.00~~ \$375.00 regardless of the number of meetings actually attended by the trustee in that month.

2. *Office of Trustee.* Any person appointed to fill a vacancy in the office of trustee shall receive the same payment sum as his or her predecessor.

C. *Clerk.* The village clerk's compensation shall be established from time to time by resolution of the village board.

D. *Treasurer.* The village treasurer's compensation shall be established from time to time by resolution of the village board.

Section 3. **Applicability.** The amendments to the salary amounts enacted pursuant to this Ordinance will apply only to those elected officials who are elected at the April 1, 2025, Consolidated Election, and elections occurring thereafter. The elected officials who were elected at the April 4, 2023, Consolidated Election will continue to receive the salary and stipend amounts that were in effect 180 days prior to the start of their terms of office.

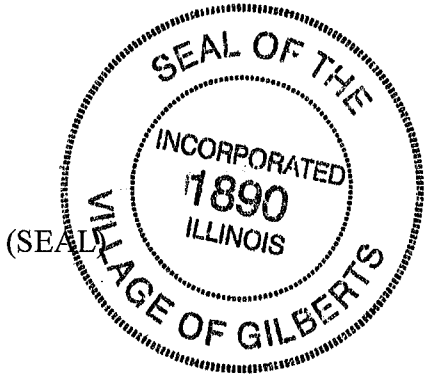
Section 4. **Repealer.** All ordinances, resolutions, or parts of ordinances or resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. **Saving Clause.** If any section, paragraph, clause, or provision of this Ordinance shall be held invalid or unenforceable by a court of competent jurisdiction, the invalidity or unenforceability thereof shall not affect the validity of the remaining provisions of this Ordinance, and the application thereof, which are hereby declared to be severable to the greatest extent permitted by law.

Section 6. **Effective Date.** This Ordinance shall be in full force and effect upon its passage, and publication required by law.
