ORDINANCE NO. 29-2018

AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED TO PAY PRINCIPAL AND INTEREST FOR \$1,975,000, GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2011 OF THE VILLAGE OF GILBERTS, KANE COUNTY, ILLINOIS.

Whereas, the Village Board (the "Board") of the Village of Gilberts, Kane County, Illinois (the "Village"), by Ordinance 25-2011, adopted on the 16th day of August, 2011,(the "Ordinance") did provide for the issue of \$1,975,000, General Obligation Bonds (Alternate Revenue Source), Series 2011, of the Village of Gilberts, Kane County, Illinois (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the Village has deposited a sufficient amount of the Pledged Revenues in the Bond Fund for the purpose of paying the debt service due on the Bonds during the next succeeding year; and

WHEREAS, it is necessary and in the best interests of the Village that the taxes heretofore levied for the year 2018 to pay debt service on the Bonds be abated:

Now, Therefore, Be It and It is Hereby Ordained by the Village Board of the Village of Gilberts, Kane County, Illinois, as follows:

Section 1. Abatement of Tax. The taxes heretofore levied for the year 2018 in the Ordinance for the Bonds, are hereby abated in their entirety so that the taxes to be extended to pay principal and interest therefore shall be Zero Dollars (\$0.00).

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of Kane County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2017 in accordance with the provisions hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect upon its adoption.
