RESOLUTION 10-2019

A RESOLUTION APPROVING THE PURCHASE OF POLICE SQUAD COMPUTERS FROM CDW-G IN AN AMOUNT NOT TO EXCEED \$16,450

WHEREAS, the Village of Gilberts ("Village") operates a Municipal Police Department; and

WHEREAS, the Village provided for the replacement of police squad car computers as part of the Fiscal Year 2020 Budget; and

WHEREAS, the Village solicited quotes for the purchase of seven (7) GETAC In Car Computer, seven (7) Havis docking stations, and seven (7) Lind Power Adapters with CDW-Government providing the lowest responsible price;

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval; Authorization. The Village Board of Trustees hereby authorizes the Village Administrator to execute the necessary documents to facilitate the purchase of seven (7) GETAC In Car Computer, seven (7) Havis docking stations, and seven (7) Lind Power Adapters for the Gilberts Police Department from CDW-G in an amount not to exceed \$16,450.

Section 3. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
