

RESOLUTION**VILLAGE OF GILBERTS****A Resolution Authorizing the Destruction of Closed Session Verbatim Recordings**

WHEREAS, pursuant to Section 2.06(a) of the Open Meetings Act, 5 ILCS 120/2.06(a), the Village of Gilberts has prepared and maintained verbatim records of its closed sessions, and prepared and approved closed session meeting minutes from these verbatim recordings; and

WHEREAS, pursuant to Section 2.06(c) of the Open Meetings Act, 5 ILCS 120/2.06(c), the Village is authorized to periodically destroy a verbatim record of a closed session not less than 18 months after the completion of that closed session and only after (1) the Village Board approves the destruction of a particular verbatim record and (2) the Village Board has approved minutes of the closed session prepared in accordance with Section 2.06(a) of the Open Meetings Act, 5 ILCS 120/2.06(a); and

WHEREAS, the Village Board desires to authorize the destruction of certain closed session verbatim records for which written minutes have been approved during the Village Board's semi-annual review conducted in accordance with Section 2.06(d) of the Open Meetings Act, 5 ILCS 120/2.06(d).

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Authorization of Destruction of Closed Session Verbatim Recordings. The Village Board hereby authorizes the Village Clerk to destroy the following verbatim records for the following closed sessions:
