

VILLAGE OF GILBERTS

A RESOLUTION REPEALING RESOLUTION NO. 18-2012 AND MEMORIALIZING THE AUTHORIZED SUPERVISORY POSITIONS IN THE GILBERTS POLICE DEPARTMENT

WHEREAS, the Village of Gilberts is an Illinois municipal corporation; and

WHEREAS, in 2012, the Village Board adopted Resolution No. 18-2012, memorializing the number of supervisory positions in the Gilberts Police Department; and

WHEREAS, the Village Board desires to repeal Resolution No. 18-2012 and adopt this Resolution updating the supervisory positions in the Police Department to implement certain changes to the supervisory structure of the Department, including elimination of the lieutenant position and establishment of a deputy chief position, as further set forth in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, KANE COUNTY, ILLINOIS, as follows:

Section 1. Recitals. The foregoing recitals are hereby incorporated into this Resolution as findings of the President and Board of Trustees.

Section 2. Repeal. The President and Village Board of Trustees hereby repeal Resolution No. 18-2012.

Section 3. Authorized Supervisory Positions in Police Department. The President and Village Board of Trustees hereby authorize the following supervisory positions in the Police Department: (1) a police chief; (2) a deputy chief; and (3) up to two sergeants. The lieutenant position is hereby eliminated; provided, however, that a police chief who is removed from the chief position may return to the position of lieutenant if he held that position prior to his appointment as police chief, in accordance with state statute.

Section 4. Effective Date. This Resolution will be in full force and effect from and after its passage and approval by a vote of the corporate authorities.
