RESOLUTION 40-2022

A RESOLUTION AUTHORIZING APPROVAL OF AGREEMENTS WITH JX PETERBUILT AND HENDERSON PRODUCTS FOR THE PURCHASE AND UPFITING OF A PETERBUILT MEDIUM DUTY 4-WHEELER TRUCK IN AN AGGREGATE AMOUNT NOT TO EXCEED AMOUNT OF \$250,000.

WHEREAS, the Village of Gilberts ("Village") has a Public Works Department that performs general maintenance operations, including snowplowing throughout the Village; and

WHERAS, in FY2022 the Village began a multi-year program to purchase a new Medium Duty 4-Wheeler to use for general maintenance and snow plowing operations; and

WHEREAS, adequate funds, including ARPA funding, were included in the FY2023 Budget for the purchase of a new Medium Duty 4-Wheeler Truck; and

WHEREAS, the Village obtained pricing though the Sourcewell joint purchasing cooperative for the purchase and upfitting;

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

- Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.
- <u>Section 2</u>. <u>Approval; Authorization</u>. The Village Board of Trustees hereby authorizes the Village Administrator to execute agreements and other necessary documents with JX Peterbuilt and Henderson Products for the purchase of a Peterbuilt Medium Duty 4-Wheeler Truck Chassis and upfit in an aggregate amount not to exceed \$250,000.
- Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the agreements with JX Peterbuilt and Henderson Products, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).
- Section 3. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
