

**VILLAGE OF GILBERTS**

**RESOLUTION 50-2022**

**A RESOLUTION AUTHORIZING APPROVAL OF AGREEMENTS WITH ALAR WATER TREATMENT LLC AND QUALITY DISTRIBUTION SERVICES FOR THE PURCHASE OF DIATOMACEOUS EARTH IN AN AGGREGATE AMOUNT NOT TO EXCEED \$33,510.**

**WHEREAS**, the Village of Gilberts (“Village”) operates a Water Treatment Plant; and

**WHEREAS**, diatomaceous earth is a necessary component of the water treatment process; and

**WHEREAS**, to ensure adequate inventory based on current supply chains and raw material availability the Village is seeking to purchase a total of 84,000lbs from two vendors; and

**WHEREAS**, the Village obtained pricing for 42,000lbs from ALAR Water Treatment Systems in the amount of \$17,735 and 42,000lbs from Quality Distribution Services in the amount of \$15,775.

**THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS**, as follows:

**Section 1.** **Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

**Section 2.** **Approval; Authorization.** The Village Board of Trustees hereby authorizes the Village Administrator to execute agreements and other necessary documents with ALAR Water Treatment Systems and Quality Distribution Services for the purchase of diatomaceous earth in an aggregate amount not to exceed \$33,510.

**Section 3.** **Waiver of Competitive Bidding.** To the extent any competitive bidding requirements apply to the agreements with ALAR Water Treatment Systems and Quality Distribution Services, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

**Section 3.** **Effective Date.** This Resolution shall be in full force and effect after its approval in the manner provided by law.
