RESOLUTION 40-2024

A RESOLUTION APPROVING THE PURCHASE OF A 2023 DODGE RAM 1500 CLASSIC SPECIAL SERVICE VEHICLE FROM LA PORTE CHRYSLER IN AN AMOUNT NOT TO EXCEED \$40,000

WHEREAS, the Village of Gilberts (“Village”) operates a Municipal Police Department which maintains a fleet of police squad vehicles; and

WHEREAS, a traffic accident involving an existing police squad vehicle has rendered it inoperable without a replacement; and

WHEREAS, the Village has sought multiple quotes from surrounding dealerships for a replacement police squad vehicle; and

WHEREAS, La Porte Chrysler Inc. has an inventory of a police squad vehicles that meet the Village’s specifications, offered the best quote for a replacement police squad vehicle, and has successfully been utilized for prior purchases by the Village.

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval; Authorization. The Village Board of Trustees hereby authorizes the Village Administrator to execute the necessary documents to facilitate the purchase of a 2023 Dodge RAM 1500 Classic Special Service Vehicle for the Gilberts Police Department from La Porte Chrysler Inc. in an amount not to exceed \$40,000.

Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the purchase of the 2023 Dodge RAM 1500 Classic Special Service Vehicle from La Porte Chrysler Inc, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.


