RESOLUTION 48-2024

**A RESOLUTION AUTHORIZING APPROVAL OF AN AGREEMENT WITH
MONROE FOR THE OUTFITTING OF THE PUBLIC WORKS 2024 FORD F-750 IN
AN AMOUNT NOT TO EXCEED \$84,000**

WHEREAS, the Village of Gilberts (“Village”) has a Public Works Department, which maintains Village streets and other Village infrastructure, which activities include snow removal operations; and

WHEREAS, the Village currently maintains a fleet of Ford trucks and snow plowing equipment; and

WHEREAS, the Village has funds in the CY2024 Budget for the purchase and outfit of a new Ford F-750 as part of the Village’s equipment Capital Improvement Plan; and

WHEREAS, in January 2024 the Village purchased a Ford F-750 chassis (Resolution 04-2024) and;

WHEREAS, the Village previously solicited quotes for the outfitting of the Ford F-750 chassis with Bonnell Industries being the most responsive, which was approved via Resolution 29-2024; and

WHEREAS, Bonnell Industries is currently booking out to 2026 on outfitings and as a result the Village solicited alternate quotes; and

WHEREAS Monroe has provided an alternate competitive quote and will be able to complete the work in 2025;

THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval; Authorization. The Village Board of Trustees hereby authorizes the Village Administrator to execute the necessary documents to facilitate the outfitting of the 2024 Ford F-750 for the Public Works Department with Monroe in an amount not to exceed \$84,000.

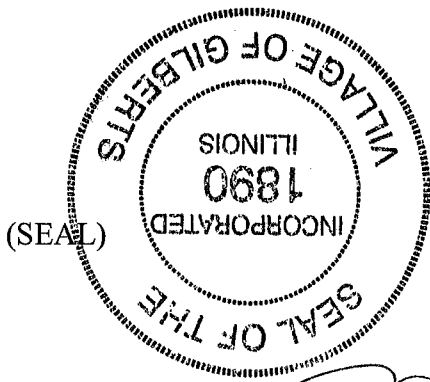
Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the outfitting of the 2024 Ford F-750 by Monroe, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

Section 4. Repealer. All ordinances, resolutions, or parts of ordinances or resolutions in conflict with this Resolution, specifically Resolution 29-2024, are hereby repealed to the extent of such conflict.

Section 5. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
