RESOLUTION 06-2025

A RESOLUTION AUTHORIZING APPROVAL OF A PURCHASE ORDER WITH VIKING CHEMICAL FOR THE PURCHASE OF WATER AND WASTEWATER TREATMENT PLANT CHEMICALS DURING CALENDAR YEAR 2025 IN AN AGGREGATE AMOUNT NOT TO EXCEED \$78,000.

WHEREAS, the Village of Gilberts (“Village”) operates a Water Treatment Plant and Wastewater Treatment Facility; and

WHEREAS, various chemicals including Alum, Fluoride, Chlorine and Muriatic Acid are necessary components of the Village’s water and wastewater treatment processes; and

WHEREAS, funds for the purchase of treatment chemicals were allocated as part of the 2025 Budget; and

WHEREAS, the Village places multiple chemical orders from Viking Chemical Company on an annual basis; and

WHEREAS, Viking Chemical Company has previously supplied treatment chemicals to the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, ILLINOIS, as follows:

Section 1. **Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

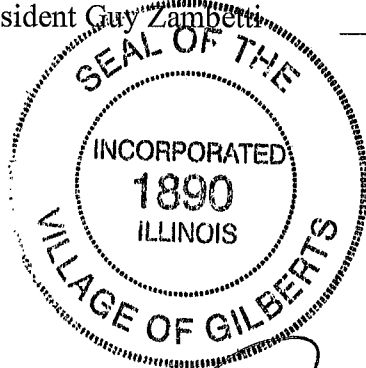
Section 2. **Approval; Authorization.** The Village Board of Trustees hereby authorizes the Village Administrator to execute agreements and other necessary documents with Viking Chemical Company for the purchase of treatment chemicals in an aggregate amount not to exceed \$78,000 during calendar year 2025.

Section 3. **Waiver of Competitive Bidding.** To the extent any competitive bidding requirements apply to the purchase of the treatment chemicals from Viking Chemical Company authorized by this Resolution, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

Section 3. **Effective Date.** This Resolution shall be in full force and effect after its approval in the manner provided by law.
