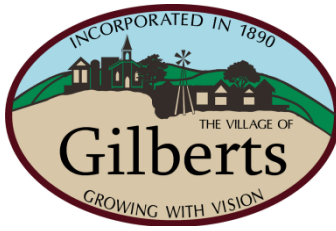

- Completed business license application and license fee of \$25.00 are required before a business license is issued. If the registration fee is not paid within one month after the due date, the fee becomes \$50.00, and if not paid within four months after the due date, the fee becomes \$75.00.
- Each business not otherwise exempted by State law shall obtain an annual license from the Village within sixty (60) days of commencing business in the Village. Business licenses expire on May 31 of each year and must be renewed prior to their expiration (Ord. 04-05, 2-3-2004; amd. 2010 Code).
- Business licenses are not transferrable without the express written consent of the Village (2006 Code § 8.5).
- No retail business may be open between the hours of 2 a.m. and 5 a.m. on any day of the year (2006 Code § 8.9).
- The Village may add your business information to our Business Directory located on the Village of Gilberts website. If you do not want your business' information added, please let us know.
