ORDINANCE NO. 19-2014

AN ORDINANCE ABATING SPECIAL SERVICE AREA TAXES FOR VILLAGE OF GILBERTS, ILLINOIS SPECIAL SERVICE AREA NUMBER NINETEEN

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GILBERTS, KANE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. It is found and declared by the President and Board of Trustees of the Village of Gilberts, Kane County, Illinois (the "Village"), as follows:

- (a) The President and Board of Trustees of the Village adopted Ordinance No. 06-58 on December 13, 2006, as supplemented by a written Determination dated December 19, 2006 (the "Series 2006 Bond Ordinance") which: (i) provided for the issuance of \$15,000,000 of Special Service Area Number Nineteen Special Tax Bonds, Series 2006-1 (The Conservancy Project) (the "SSA No. 19 Bonds") of the Village of Gilberts for the purpose of paying the costs of certain improvements benefiting the Village's Special Service Area Number Nineteen (the "Special Service Area"); and (ii) provided for the levy of Special Taxes upon all taxable property within the Special Service Area sufficient to pay the principal of the SSA No. 19 Bonds for each year at maturity or mandatory sinking fund redemption dates and to pay interest and Administrative Expenses of the Special Service Area for each such year.
- (b) On August 19, 2014 the Village issued its Special Service Area Number Twenty Four Special Tax Bonds, Series 2014 (the "Series 2014 Bonds") pursuant to which the Village refunded and restructured the outstanding principal amount of the SSA No. 19 Bonds. Ordinance No. 11-2014 of the Village adopted on May 20, 2014, pursuant to which the Series 2014 Bonds were issued, provided for a separate levy for payment of debt service on the Series

2014 Bonds and directed the Village to adopt and file an abatement ordinance abating the levy of taxes for levy year 2014 for the SSA No. 19 Bonds, upon the issuance of the Series 2014 Bonds.

Section 2. There is hereby abated all taxes levied pursuant to the Series 2006 Bond Ordinance (Ordinance No. 06-58) for levy year 2014.

Section 3. It is the duty of the County Clerk of Kane County to abate those taxes for levy year 2014 as provided in Section 2 of this Ordinance.

Section 4. All ordinances, resolutions and orders or parts of ordinances, resolutions and orders in conflict with this ordinance are repealed to the extent of such conflict. The Village Clerk shall cause this Ordinance to be published in pamphlet form. This Ordinance shall be in full force and effect after passage and publication as provided by law.

Section 5. A copy of this Ordinance shall be filed with the County Clerk of Kane County.
